I am pleased to inform your Honorable Body that I have signed into law this day the following bills which are routine and require no special treatment:

Bill 21-0040 - An Ordinance Concerning - Flood Plain Management Code - Revision- For the purpose of modifying the City laws governing floodplain management to meet or exceed requirements for eligibility in the National Flood Insurance Program and other requirements of Federal and State law; incorporating certain flood-resistant design and construction standards adopted by the American Society of Civil Engineers; defining and redefining certain terms; repealing redundant, obsolete, or otherwise superfluous provisions; correcting and conforming certain obsolete nomenclature; providing for a special effective date; and generally relating to the protection, maintenance, and enhancement of the public health, safety, and welfare through floodplain management.

Bill 21-0026 - An Ordinance Concerning - Rezoning - 1201 South Caton Avenue - For the purpose of changing the zoning for the property known as 1201 South Caton Avenue (Block 2108C, Lot 002), as outlined in red on the accompanying plat, from the EC-1 Zoning District to the I-1 Zoning District; and providing for a special effective date.

INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 21-0090 - By The Council President (The Administration (Department of Transportation))

An Ordinance condemning and closing of Etting Street and four ten-foot alleys bounded by Druid Hill Avenue, Gold Street, Division Street and Baker Street as shown on a plat numbered 337-A-28A and filed in the Office of the Department of Transportation; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Planning, Department of Housing and Community Development, Department of Transportation, Baltimore Development Corporation, and the Economic and Community Development Committee.

Bill No. 21-0091 - By The Council President (The Office of the Comptroller)

An Ordinance authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain property located at NES Broening Highway 844-1 ft. SE of

Colgate Creek (Block 6997, Lot 002) and no longer needed for public use; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Planning, Department of Housing and Community Development, Department of Transportation, Department of Real Estate, Parking Authority, Department of Finance, and the Ways and Means Committee.

Bill No. 21-0092 - By Councilmembers Burnett, Cohen, Dorsey

An Ordinance authorizing the establishment of a continuing, nonlapsing Homegrown Heroes Fund, to be used exclusively to administer a Public Safety Apprenticeship Program for youth and young adults who are Baltimore City residents and between the ages of 11 through 21 years old; requiring that the annual Ordinance of Estimates include a specified appropriation for the Homegrown Heroes Fund; and submitting this amendment to the qualified voters of the City for adoption or rejection.

The bill was read the first time and referred to the City Solicitor, Department of Finance, and Ways and Means Committee.

Bill No. 21-0093 - By Councilmember Dorsey (The Administration), Councilmembers Cohen, Burnett, Ramos

An Ordinance updating Article 1, Subtitle 8 {Whistleblower Rights and Responsibilities} of the City Code to define certain terms; requiring a whistleblower to report their complaint to their agency's personnel officer or to the Office of the Inspector General if the whistleblower has a reasonable and articulable belief that the personnel officer cannot competently investigate the covered disclosure; requiring the Office of the Inspector General to give written notice of investigation or a notice of declination to the whistleblower within 30 days of receipt of the complaint; requiring the Office of the Inspector General, if initiating an investigation, to send a Memorandum of Protected Activity to the whistleblower's supervisor; requiring the Office of the Inspector General to provide recommendations for action in the Office's written findings of an investigation and to give the written findings to the City Administrator, the agency head, and the whistleblower; requiring the City Administrator to hold a meeting with the agency head and the Inspector General to discuss the recommendations within a certain amount of time; providing possible remedies in case of a violation of this subtitle; and conforming and clarifying related provisions.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Office of the Inspector General, Department of Human Resources, City Administrator, and the Rules and Legislative Oversight Committee.

Bill No. 21-0094 - By Councilmembers Burnett, Cohen, Dorsey

An Ordinance purpose of providing for the establishment and implementation of a Public Safety Apprenticeship Program for Baltimore City; providing for the development and oversight of the Program by the Baltimore City Fire Department in partnership with certain other public safety agencies in Baltimore City; establishing the purposes of the Program; and requiring that the Baltimore City Fire Department report annually certain information to the Mayor and City Council and requiring the report to be made available on the Department's website.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Fire Department, Baltimore Police Department, Office of Emergency Management, Sheriff's Office, Baltimore City Public School System, and the Public Safety and Government Operations Committee.

Bill No. 21-0095 - By Councilmembers Burnett, Cohen, Dorsey

An Ordinance requiring certain contractors with the City of Baltimore to place a notice regarding the human-trafficking prevention hotline in certain locations; providing that certain contractors may obtain the required human-trafficking notices from the United States Department of Homeland Security's Blue Campaign website; providing for certain penalties; and generally relating to labor trafficking notice requirements for city contractors.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Baltimore Police Department, Mayor's Office of Neighborhood Safety and Engagement, Health Department, Mayor's Office of Homeless Services, and the Public Safety and Government Operations Committee.

Bill No. 21-0096 - By Councilmember Schleifer

An Ordinance adopting a provision of the International Building Code exempting certain one story detached accessory structures used as tool and storage sheds, playhouses and similar uses from construction permitting requirements; and conforming related provisions.

The bill was read the first time and referred to the City Solicitor, Department of Planning, Department of Housing and Community Development, Department of Transportation, Baltimore Development Corporation, Baltimore City Fire Department, Department of Public Works, Board of Municipal and Zoning Appeals, and the Rules and Legislative Oversight Committee.

Bill No. 21-0097 - By Councilmembers Middleton, Dorsey, Cohen, Torrence, Porter, Bullock, Stokes

An Ordinance establishing the Emergency Security Deposit Voucher Program; placing a cap on the amount of money the Emergency Security Deposit Voucher Program can give each family for a security deposit; providing for certain funding for the Emergency Security Deposit Voucher Program; setting forth the eligibility requirements for the Emergency Security Deposit Voucher Program; requiring that the Department of Housing and Community Development adopt rules and regulations to administer the Emergency Security Deposit Voucher Program; establishing procedures on a family's admission into the Emergency Security Deposit Voucher Program; putting certain priorities in place for distribution of security deposit vouchers; requiring the security deposit voucher to be used within a certain time frame; making a family liable for the cost of the security deposit voucher upon a Departmental finding that the family has used the security deposit voucher improperly; providing for an appeals process in case of a finding of improper use of the security deposit voucher or denial of a security deposit voucher; defining certain terms; and providing for termination of this subtitle on a certain date.

The bill was read the first time and referred to the City Solicitor, Department of Housing and Community Development, Department of Finance, and the Economic and Community Development Committee.

The President laid before the City Council the following Council Resolutions for first reading:

Bill No. 21-0046R - By Councilmembers Burnett, Conway, Cohen, Dorsey

A Resolution inviting representatives from the Baltimore Police Department, the Mayor's Office of Neighborhood Safety and Engagement, the Department of Transportation, the Law Department, the Office of the Comptroller, the Department of Finance, the Baltimore City State's Attorney's Office, the Office of the Public Defender for Baltimore City, the Baltimore Development Corporation, and concerned parties from Baltimore's legal, academic, security, and non-profit sectors to discuss the use of facial recognition technology in Baltimore and any local legislative options for the Baltimore City Council to consider in order to balance public safety, privacy, and individual civil liberties.

The bill was read the first time and referred to the Comptroller, City Solicitor, Department of Transportation, Baltimore Development Corporation, Department of Finance, Baltimore Police Department, Mayor's Office of Neighborhood Safety and Engagement, Baltimore City State's Attorney's Office, and the Health, Environment, and Technology Committee.

Bill No. 21-0047R - By Councilmembers Burnett, Cohen, Dorsey

A Resolution requesting the Director of the Department of Recreation and Parks, the Director of the Department of Planning, the Director of the Department of Transportation, the Director of the Department of Housing and Community Development, the Head of the Bureau of Solid Waste, the Sustainability Coordinator, a representative from the Office of the Comptroller, and the Chief of the Bureau of Budget and Management Research to report on the annual cumulative total of calls for service for the upkeep and maintenance of vacant lots and green spaces; and recommending to the Administration that a single City agency be charged with the responsibility for mowing all Cityowned lots, parcels, parks, and green spaces.

The bill was read the first time and referred to the City Solicitor, City Administrator, Department of Planning, Housing and Community Development, Department of Transportation, Department of Finance, Department of Public Works, Office of the Comptroller, Baltimore City Recreation and Parks, Office of Sustainability, and the Education, Workforce, and Youth Committee.

Bill No. 21-0048R - By Councilmember Middleton

Introduced: June 8, 2021 (Read and adopted)

A COUNCIL RESOLUTION CONCERNING

Request for Federal Action – End the Embargo Against Cuba

FOR the purpose of urging Congress and the President to immediately end all aspects of the United States' economic, commercial and financial embargo against Cuba, including restrictions on travel to Cuba by United States citizens; urging the United States government to remove the Republic of Cuba from the United States' list of state sponsors of terrorism; and urging the return of the Guantanamo Bay property to the Republic of Cuba.

WHEREAS, Starting in October 1960, the United States government imposed an economic, commercial, and financial embargo on Cuba, amounting to a blockade;

WHEREAS, the U.S. embargo against Cuba continues to inflict hardship on the people of Cuba by creating shortages of food and financial and trade opportunities, and is thus in violation of the Universal Declaration of Human Rights;

WHEREAS, the embargo denies U.S. citizens access to advanced Cuban medicines and medical technologies that Cuba willingly shares and implements all over the world, especially in developing countries;

WHEREAS, an end to the embargo would renew diplomatic relations between the U.S. and Cuba, allowing for a significant expansion of international trade, direct travel for the citizens of both countries, dialogue on human rights, and direct mail services, including the reinstatement of family remittances;

WHEREAS, for 28 consecutive years, the General Assembly of the United Nations has adopted an annual resolution in favor of lifting the U.S. embargo against Cuba;

WHEREAS, the City of Baltimore has historically enjoyed medical, labor, cultural, sports, and interpersonal exchanges with Cuba, including medical exchanges with the Johns Hopkins Hospital and University, Baltimore-Cuba baseball games, performances by Cuban musicians Buena Vista Social Club at the Baltimore Meyerhoff Symphony Hall, and being sister cities with Matanzas;

WHEREAS, normalization of relations with Cuba would continue to enrich Baltimore's cultural, historical, and economic life; and

WHEREAS, Cuba's material support helped abolish apartheid in South Africa and the Baltimore City Council played a significant role in the divestment from apartheid South Africa.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the Council urges Congress and the President to immediately end all aspects of the United States' economic, commercial, and financial embargo against Cuba, including restrictions on travel to Cuba by U.S. citizens, to remove Cuba from the United States' list of state sponsors of terrorism, and return the property of Guantanamo Bay to Cuba.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the President of the United States, the Maryland Congressional Delegation, the Baltimore City Delegation to the General Assembly, the Mayor, the Baltimore City Council President, the City Council President's legislative staff, and the Mayor's Legislative Liaison to the City Council.

Councilmember Middleton made a motion, which was duly seconded, that the Rules be suspended.

There being no objection, the President declared that the Rules were suspended.

Then Councilmember Middleton made a motion, which was duly seconded, that the Resolution be adopted.

A Resolution inviting representatives from ROCA, Safe Streets, the Baltimore Police Department's Group Violence Prevention Strategy, and 911 Diversion Program, and the Mayor's Office of Neighborhood Safety and Engagement to inform the City Council about the existing alternatives to policing strategies the City has in its arsenal.

The bill was read the first time and referred to the City Solicitor, City Administrator, Baltimore Police Department, Mayor's Office of Neighborhood Safety and Engagement, Health Department, and the Public Safety and Government Operations Committee.

An Ordinance requiring, absent certain good cause circumstances, landlords to offer tenants a reasonable opportunity renew leases; providing for the manner of notice for which a landlord must send renewal notices or decline-to-renew notices; establishing a presumption of offer and acceptance, absent certain circumstances; providing for the effect of the subtitle; providing for certain administrative and criminal penalties; and providing for a special effective date.

Favorable report, as amended, adopted. Councilmember Costello and Councilmember McCray voted no. Councilmember Burnett abstained.

BILL No. 21-0044R REPORTED FAVORABLY AND ADOPTED

Councilmember McCray, for the Health, Environment, and Technology Committee, reported Bill No. 21-0044R favorably.

A Council Resolution Concerning

Informational Hearing - COVID-19 and Mental Health

FOR the purpose of inviting representatives from the Baltimore City Health Department, the Mayor's Office of Children and Family Success, the Mayor's Office of Homeless Services, and members from the Baltimore City healthcare community to appear before the Baltimore City Council to discuss the financial, physical, and social impacts that COVID-19 has had on the mental health of Baltimore City residents and what resources are available to help people cope and recover from this trauma.

Recitals

When recognizing the various ways that feelings of isolation and poor mental health can lead to depression as well as a series of adverse physical health, it is increasingly important to acknowledge the ways in which living during a pandemic can negatively affect mental health and trigger depression, higher risks of mortality, and increased levels of inflammation that lead to chronic health conditions. We also must recognize the impact on mental health for survivors of COVID-19 and family members of the over 900 members of our communities who have lost their lives due to the Coronavirus.

Living under COVID-19, residents have not only spent increased amounts of time isolated from those they love, but they have had to deal with the general stresses that come with living during a pandemic. These stresses may be related to worry or fear about oneself or a loved one contracting the virus, especially those with a pre-existing medical condition. There may be the stress of not knowing when the pandemic will end and feeling like they have no control of how the situation affects their life.

The contagion of COVID-19 has left our residents without the warmth of their loved ones, and instead with indefinite periods of isolation and loneliness. As we continue to prioritize stopping the spread of the Coronavirus, we must address the consequences that quarantine, toll and stress of financial uncertainty, restrictions in social and family gatherings, disruption of non-essential services delivery, and suspension of cultural and sporting activities can have on mental health, and the various ways in which mental health impacts mental and physical well-being.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the Council invites representatives from the Baltimore City Health Department, the Mayor's Office of Children and Family Success, the Mayor's Office of Homeless Services, and members from the Baltimore City healthcare community to appear before the Baltimore City Council to discuss the financial, physical, and social impacts that COVID-19 has had on the mental health of Baltimore City residents and what resources are available to help people cope and recover from this trauma.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Mayor, the Baltimore City Health Commissioner, the Executive Director of the Mayor's Office of Children and Family Success, the Acting Director of the Mayor's Office of Homeless Services, the President of the Maryland Hospital Association, and the Mayor's Legislative Liaison to the Baltimore City Council.

BILL NO. 21-0001 REPORTED FAVORABLY, WITH AMENDMENTS, AND ORDERED PRINTED FOR THIRD READER

Councilmember Conway, for the Public Safety and Government Operations Committee, reported Bill No. 21-0001 favorably, with amendments.

An Ordinance prohibiting Baltimore City government from purchasing or obtaining certain face surveillance technology; prohibiting Baltimore City government from contracting or subcontracting with another for the purpose of face surveillance technology; prohibiting any person in Baltimore City from obtaining, retaining, accessing, or using certain face surveillance technology or any information obtained from certain face surveillance technology; requiring the Director of Baltimore City Information and Technology to submit an annual report to the Mayor and City Council regarding the use of surveillance by the Mayor and City Council; providing for certain termination dates; providing for certain penalties; and defining certain terms.
