FOR the purpose of inviting the Acting Director of the Mayor’s Office of Homeless Services, the Director of the Mayor’s Office of Children and Family Success, the City Administrator, and the Acting Commissioner of the Department of Housing and Community Development, ~~and the advocacy groups Housing Our Neighbors and Homeless Persons Representation Project~~ to brief and advise the City Council as to: the overall outcomes for neighbors experiencing homelessness who were able to reside in the hotels; what is next for them; assistance for those experiencing homelessness in encampments during the crisis; and the availability of programs to access housing.

Recitals

WHEREAS, the COVID-19 pandemic is a serious health crisis in our City, State, and Nation;

WHEREAS, the Mayor's Office of Homeless Services has housed over 500 of our neighbors experiencing homelessness in local hotels to allow some to recover from COVID as well as to protect others from COVID;

WHEREAS, many more of our neighbors experiencing homelessness need protection from the ongoing crisis and need access to stable housing;

WHEREAS, the Federal Emergency Management Agency (FEMA) may reimburse cities for temporary hotel stays for our neighbors experiencing homelessness now and throughout the health crisis; an

WHEREAS, there is interest for the public and the City Council to be briefed on the plan for our neighbors experiencing homelessness both in hotels and in encampments to be stably housed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the Council invites the Acting Director of the Mayor's Office of Homeless Services, the Director of the Mayor's Office of Children and Family Success, the City Administrator, and the Acting Commissioner of the Department of Housing and Community Development, ~~and the advocacy groups Housing Our Neighbors and Homeless Persons Representation Project~~ to brief and advise the City Council as to: the overall outcomes for neighbors experiencing homelessness who were able to reside in the hotels; what is next for them; assistance for those experiencing homelessness in encampments during the crisis; and the availability of programs to access housing.

**Investigative Hearing - Vacant Residential Properties -
Requirement for Homeowners Insurance**

FOR the purpose of inviting the Director of the Department of Housing and Community Development, the City Administrator, the City Solicitor, the Maryland Insurance Commissioner, the Baltimore City Comptroller, and the President and CEO of the Baltimore Development Corporation to testify regarding requiring owners of vacant residential properties to obtain homeowners insurance.

Recitals

WHEREAS, privately-owned, vacant residential properties that have been left in a state of disrepair or have not been properly maintained are a continuing problem in Baltimore City;

WHEREAS, many of these properties are located in populated communities and are adjacent to other commercial and residential properties;

WHEREAS, long-term disrepair or neglect of a vacant residential property may cause physical injury to those in the community or damage to adjacent properties; and

WHEREAS, the citizens and property owners of Baltimore City should have recourse if a person's neglect of a vacant property leads to physical injury or property damage, and filing a claim against a property owner's homeowners insurance could provide such recourse.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City Council invites the Director of the Department of Housing and Community Development, the City Administrator, the City Solicitor, the Maryland Insurance Commissioner, the Baltimore City Comptroller, and the President and CEO of the Baltimore Development Corporation to testify regarding requiring owners of vacant residential properties to obtain homeowners insurance.

A COUNCIL RESOLUTION CONCERNING

Global Warming Solutions - Carbon Neutral City

FOR the purpose of calling on the Mayor, the Baltimore City Council, the Baltimore City Administrator, the Baltimore Office of Sustainability, and the Baltimore Commission on

Sustainability to take all necessary actions to ~~make Baltimore a carbon neutral city by 2050~~ achieve a 30% reduction in City carbon emissions by 2025, a 60% reduction in City carbon emissions by 2030, and to make Baltimore a carbon neutral city by 2045, while minimizing carbon offsets.

Recitals

Baltimore City is responsible for promoting the public health and safety of its residents, including ensuring citizens have access to clean air, clean water, and a livable environment.

The International Energy Agency's 2021 Global Energy Review estimates that carbon dioxide ("CO₂") emissions will increase by almost 5% this year to 33 billion metric tons, based on the latest national data from around the world, as well as real-time analysis of economic growth trends and new energy projects that are set to begin operations. This is the second-largest increase in history – reversing most of the decline caused by the COVID-19 pandemic in 2020. The key driver of this increase is coal demand, which is set to grow by 4.5%, surpassing its 2019 level and approaching its all-time peak from 2014. The electricity sector accounts for three-quarters of this increase.

In 2017, Baltimore was responsible for the emission of 7,487,000 metric tons carbon dioxide equivalent ("CO₂ eq"). The stationary energy sector contributes 72% of Baltimore's total emissions, while 25% are from transportation within Baltimore, and 3% of emissions are generated by waste management.

On April 22, 2019, the Mayor signed The 2019 Baltimore Sustainability Plan. The Plan is composed of recommended strategies to meet Baltimore's goal to mitigate global climate change. In the Plan, Baltimore committed to achieving reductions in greenhouse gas emissions similar to goals set by the Paris Climate Agreement; including a 25% reduction by 2020 and a 30% by 2025 (relative to 2007). Despite this goal, in comparison to the 2007 baseline established by the Baltimore Office of Sustainability (8,570,000 metric tons CO₂ eq), emissions in Baltimore have only reduced by 13%.

While the rise of global emissions are a serious threat to all, adverse effects from a changing atmosphere can compound existing poverty in a city like Baltimore, where almost 35% of households earn less than \$25,000 annually. The City's initiative to reduce greenhouse gases can alleviate health burdens made worse by pollutants, and reduce added stressors that greatly impact residents in neighborhoods with concentrated poverty. While it is possible for cities to achieve their interim carbon reduction targets through incremental improvements to existing systems, achieving carbon neutrality requires robust, transformative changes to core city systems.

Baltimore cannot wait. The costs of delay are too great. Our City is resolved to act now. Climate change threatens our City, as it does the world. Baltimore must become a Carbon Neutral City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City Council calls on the Mayor, the Baltimore City Administrator, the Baltimore Office of Sustainability, and the Baltimore Commission on Sustainability to take all necessary actions to ~~make Baltimore a carbon neutral city by 2050~~ achieve a 30% reduction in City carbon emissions

by 2025, a 60% reduction in City carbon emissions by 2030, and to make Baltimore a carbon neutral city by 2045, while minimizing carbon offsets.
