I am pleased to inform your Honorable Body that I have signed into law this day the following bills:

**Bill 21-0095** -Labor Trafficking - Notice Requirements - For the purpose of requiring certain contractors with the City of Baltimore to place a notice regarding the human-trafficking prevention hotline in certain locations; providing that certain contractors may obtain the required human-trafficking notices from the United States Department of Homeland Security's Blue Campaign website; providing for certain penalties; and generally relating to labor trafficking notice requirements for city contractors.

**Bill 21-0098** - Zoning - Conditional Use Conversion of a Single Family Dwelling Unit to 5 Dwelling Units in the R-8 Zoning District - Variances - 1100 West Lafayette Avenue - For the purpose of permitting, subject to certain conditions, the conversion of a single-family dwelling unit to 5 dwelling units in the R-8 Zoning District on the property known as 1100 W. Lafayette Avenue (Block 0079, Lot 001), as shown on the accompanying plat with the lot number circled.

**Bill 21-0108** - For the purpose of changing the name of James Mosher Elementary School, located at 2400 Mosher Street, to Billie Holiday Elementary School.

**Bill 21-0109** - For the purpose of changing the name of Calverton Elementary/Middle School, located at 201 North Bend Road, to Katherine Johnson Global Academy.

**Bill 21-0116** - For the purpose of changing the zoning for the property known as Block 3518A, Lot 001, as outlined in red on the accompanying plat, from the TOD-2 Zoning District to the IMU-2 Zoning District.

#### INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 22-0194 - By Councilmembers Ramos and Stokes

A Mayor and City Council Resolution renewing and continuing the Charles Village Community Benefits District and Management Authority; providing for a special effective date; and generally relating to the activities and authority of the Charles Village Community Benefits District and Management Authority.

The bill was read the first time and referred to the Economic and Community Development Committee.

**Bill No. 22-0195 -** By President Mosby and Councilmembers Ramos, Dorsey, Glover, Conway Bullock, Torrence, Middleton, Stokes, Cohen

An Ordinance defining certain terms; repealing certain findings and policy statements; repealing rules of statutory interpretation that have been superseded by the enactment of Code-wide revisions; requiring the Commissioner of the Department of Housing and Community Development to adopt an inclusionary housing manual; requiring annual reporting by the Commissioner of the Department of Housing and Community Development; amending the duties

of the Inclusionary Housing Board; amending certain affordability requirements; clarifying a certain City policy regarding mixed income communities; repealing off-site substitutions; repealing the Inclusionary Housing Offset Fund; repealing density bonuses; requiring residential projects to submit inclusionary housing plans; amending requirements for continued affordability; clarifying the applicability of certain fair housing laws and regulations; establishing certain penalties; and generally relating to inclusionary housing.

The bill was read the first time and referred to the Committee of the Whole.

**Bill No. 22-0196 -** By President Mosby and Councilmembers Ramos, Glover, Conway, Bullock, Middleton, Cohen, Burnett

An Ordinance establishing the Short-Term Rental Assistance Program; delivering short-term rental assistance to families experiencing housing emergencies; creating a maximum amount of rental assistance paid to any 1 family per month; creating a maximum duration that any 1 family may receive rental assistance under the Program; establishing eligibility requirements for the Program; requiring the Department of Housing and Community Development to adopt rules and regulations to administer the Program; establishing admission standards for the Program; providing for an appeals process in case of an application denial; defining certain terms; and providing for a special effective date.

The bill was read the first time and referred to the Committee of the Whole.

The President laid before the City Council the following Council Resolutions for first reading:

**Bill No. 22-0088R -** By Councilmembers Porter, Bullock, Stokes, Torrence, Cohen, Ramos, Glover, Burnett

A Resolution inviting representatives from the CSX Transportation, Inc., incorporated under the general law of the laws of the Commonwealth of Virginia, the Baltimore Fire Department, and the Office of Emergency Management to investigate the cause of the CSX Coal Silo explosion that occurred on December 30, 2021, in Curtis Bay, to address what is being done about air quality in the area, and how an incident of this type may be prevented in the future.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

#### Request for State Action - Full Funding for Baltimore City Public Schools

FOR the purpose of calling on Governor Lawrence J. Hogan to fully fund the Baltimore City Public Schools to the levels established by the Blueprint for Maryland's Future and as required by state law.

The Constitution of Maryland mandates the "thorough and efficient" funding of public schools throughout the state. Every year the State of Maryland and the Mayor and City Council of Baltimore provide funding for the operations of the Baltimore City Public School System. Historically, this funding has not been sufficient to meet the educational needs of every Baltimore City student.

For three years, the Commission on Innovation and Excellence in Education (the Kirwan Commission) brought together a wide range of experts and local leaders to develop policy and funding recommendations that would ensure Maryland schools in every local jurisdiction provided an adequate education to every student. In 2020, the Maryland General Assembly passed The Blueprint for Maryland's Future, legislation to put the recommendations of the Kirwan Commission into practice. In 2021, the General Assembly went on to override Governor Hogan's veto of the Blueprint legislation, making the funding formulas contained in the bill state law.

The Baltimore City Council has repeatedly affirmed its commitment to the Blueprint for Maryland's Future, having called for an override of Governor Hogan's veto of the legislation and holding hearings to assess Baltimore's fiscal readiness for additional education funding obligations. The City Council believes that adequately-funded public education is a tremendous tool to combat the impacts of concentrated poverty. The City Council further believes that, once fully implemented, the Blueprint for Maryland's Future will have an immeasurable impact on the lives of and educational outcomes for Baltimore City public school students.

In January of 2022, Governor Hogan released his proposed budget for Fiscal Year 2023. His budget did not contain mandated funding for several Blueprint initiatives, including the Education Effort Adjustment index intended to more equitably share between the state and Baltimore City the increased financial commitment to our students. This component of the state education funding formula was expected to provide an additional \$99 million in funding to Baltimore City schools. The Governor is required by law to provide this funding.

At a time when the State of Maryland expects to realize an unprecedented budget surplus, the City Council sees no justification for the Governor to not provide this funding as required.

**Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, That the Baltimore City Council urges Governor Lawrence J. Hogan to immediately take all necessary action to fully fund the Blueprint for Maryland's Future and satisfy all education funding requirements mandated by state law.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Governor of Maryland, the Secretary of the Department of Budget and Management, the President of the Maryland Senate, the Speaker of the Maryland House of Delegates, the Baltimore City Delegation to the General Assembly, the Mayor, the Baltimore City Council President, the President's legislative staff, and the Mayor's Legislative Liaison to the City Council.

Councilmember Costello made a motion, which was duly seconded, that the Rules be suspended.

# BILL NO. 21-0162 REPORTED FAVORABLY, WITH AMENDMENTS, AND ORDERED PRINTED FOR THIRD READING

Councilmember Middleton, for the Economic and Community Development Committee, reported Bill No. 21-0162 favorably, with amendments.

An Ordinance amending the Urban Renewal Plan for Brooklyn-Curtis Bay to extend the time the Urban Renewal Plan for Brooklyn-Curtis Bay remains in full force and effect; amending the Urban Renewal Plan for Brooklyn-Curtis Bay to reauthorize the acquisition of properties within the Project Area and to extend the life of the Plan; waiving certain content and procedural requirements; making the provisions of this Ordinance severable; providing for the application of this Ordinance in conjunction with certain other ordinances; and providing for a special effective date.

An Ordinance correcting various errors and omissions in the City Code; correcting, clarifying and conforming certain inconsistent, superfluous, vague, ungrammatical, misnumbered, and other unclear language; and providing for a special effective date.

(iii) dwelling unit that, even if occupied, is not designated by the

State Department of Assessments and Taxation as the owner's

[principle] PRINCIPAL residence in accordance with the criteria
governing the State Homestead Tax Credit."

#### Amendment No, 2

On page 2, in line 19, after "6-8(b),", insert "6B-1(g),"; and, on page 13, before line 1, insert:

#### "Subtitle 6B. Security Deposit Grants

#### § 6B-1. Definitions.

(g) Security deposit grant; Grant.

"Security deposit grant" or "grant":

- (1) means a one-time payment by the Program of up to \$2,000 toward a security deposit; and
- (2) [shall] IS not [be] considered income [for] TO the tenant IN

  DETERMINING THE TENANT'S INCOME ELIGIBILITY, [subject to]

  UNLESS OTHERWISE REQUIRED BY any state or federal law [governing]

  THAT GOVERNS the source of funds for this [voucher] GRANT."

**COMMENT:** Clarifies the *qualified* scope of the clause that excludes the "grant" from being considered "income" in determining a tenant's income eligibility for this Program. Also, conforms terminology ("grant" in place of "voucher"), as otherwise uniformly used throughout this subtitle.

#### "Subtitle 17. Street Vendors

#### § 17-1. Definitions.

### (b) Department.

"Department" means the BALTIMORE CITY Department of [General Services] TRANSPORTATION.

#### § 17-4. Rules and regulations.

### (a) Department may adopt.

Subject to Title 4 {"Administrative Procedure Act – Regulations"} of the City General Provisions Article, the Department OF TRANSPORTATION may adopt rules and regulations to carry out this subtitle.

#### (b) *Public hearing and comment.*

In accordance with General Provisions Article § 4-301, the [Board]

DEPARTMENT OF TRANSPORTATION must publish, for public hearing and comment, notice of all rules and regulations proposed for adoption under this subtitle.

# § 17-5. Mobile vending zones.

#### (a) Designation.

#### (1) In general.

[At the request of the Department of General Services, and after] AFTER public notice has been provided to area business and neighborhood organizations, the Director of Transportation may designate spaces on City streets or other public property as "mobile vending zones" for the exclusive use of mobile vendors during designated hours.

#### (c) Temporary relocation or suspension.

The [Department of General Services or] Department of Transportation may temporarily relocate or suspend mobile vending zones at any time due to emergencies or to further public safety, public health interests, or City operations.

### § 17-15. License required.

No street vendor may operate in Baltimore City without first having obtained a license to do so from the Department of [General Services] TRANSPORTATION.

#### § 17-17. Limitations and conditions.

#### (a) In general.

The Department of [General Services] TRANSPORTATION may impose reasonable limitations and conditions on any license issued under this subtitle, as necessary or proper to carry out the purpose and intent of this subtitle.

#### § 17-18. Applications.

#### (a) Form.

An application for a license must be made in the form the Department of General Service] TRANSPORTATION requires.

### (b) Contents.

The application must contain:

<u>. . .</u>

(6) any other information the Department of [General Services]

TRANSPORTATION requires.

#### § 17-19. Term and renewal.

- (b) Renewal.
  - (2) A renewal application must be:
    - (i) in the form the Department of [General Services]

      TRANSPORTATION requires; and
    - (ii) submitted to the Department, with the applicable annual fee, at least 30 days before the current license expires.

### § 17-20. Temporary licenses.

(a) In general.

The Department of [General Services] TRANSPORTATION may issue a temporary license to be used in connection with a charitable, educational, artistic, civic, or other public function or activity.

#### § 17-24. Vendor identification – In general.

(b) Department to issue.

The Department of [General Services] TRANSPORTATION must issue an identification badge for each license issued.

#### § 17-25. Vendor identification – Country growers.

- (c) Sign.
  - (1) Instead of the badge provided for in § 17-24 {"Vendor identification In general"} of this subtitle, the Department of [General Services]

    TRANSPORTATION must provide the producer or grower with a sign to be displayed on his or her vehicle.

#### § 17-34. Mobile food vendors – Operating without logbook.

(b) Form of logbook.

The logbook must:

(1) be in the form the Department of [General Services]

TRANSPORTATION requires; and

<u>. . . .</u>

### § 17-36. All vendors – Between midnight and 6 a.m.

(b) Exception.

Subsection (a) of this section does not apply to a street vendor operating between the hours of midnight and 6 a.m. in accordance with the terms and conditions of a special event permit from the Department of [General Services] Transportation that explicitly grants permission to operate during those hours.

# § 17-44. Revocations and suspensions.

(a) Authorized suspension or revocation.

The Department of [General Services] TRANSPORTATION may suspend or revoke a license if the licensee violates any provision of:

#### § 17-45. Administrative appeals.

(a) Right of appeal.

An aggrieved party may appeal to the Board of Municipal and Zoning Appeals:

, , ,

(2) any other decision or ruling by [the] the Department of [General Services] TRANSPORTATION relating to the administration of this subtitle."
