INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 22-0286 - By City Council President (Administration - Office of the Comptroller)

An Ordinance authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain properties located at South Side Boston Street, South West Corner, and South Newkirk Street (Block 6587, Lot 008A) and South Side Boston Street, South East Corner, and South Newkirk Street (Block 6587A, Lot 016) and are no longer needed for public use; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

Bill No. 22-0287 - By Councilmember Bullock, Middleton, Torrence

An Ordinance requiring certain disclosures in order to sell a property that is located in a historic district; and providing for certain penalties.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 22-0288 - By Councilmember Torrence

An Ordinance permitting, subject to certain conditions, the conversion of a single-family dwelling unit into 3 dwelling units in the R-8 Zoning District on the property known as 2905 Parkwood Avenue (Block 3232A, Lot 003), as outlined in red on the accompanying plat; and granting variances from certain bulk (lot area size), and off-street parking requirements.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 22-0140R - By Councilmember Ramos, Middleton, Bullock, Porter, Cohen, Dorsey

A Resolution inviting representatives from the Department of Housing and Community Development, the Office of the City Administrator, the Baltimore City Fire Department, Office of the Fire Marshal, and other relevant parties to provide information on reforms to the Department of Housing and Community Development's permit process.

Bill No. 22-0141R - By Councilmember Cohen, Middleton, Torrence, Porter, Burnett, Dorsey

A Resolution inviting the City Solicitor, the City Administrator, the Director of the Baltimore City Department of Human Resources, the Baltimore City Labor Commissioner, and the Director of the Mayor's Office of Employment Development to brief the City Council regarding the practice of requiring certain degrees for certain City positions and to discuss if eliminating such a degree requirement would be detrimental or beneficial to the recruitment and retention of quality City employees.

Committee Amendments to City Council Bill No. 22-0104R

Amendment No. 1

On page 2, strike beginning with "Baltimore" in line 9 down through and including "Labor" in line 10 and substitute "Baltimore City Labor Commissioner".

The amendments were read and adopted.

Informational Hearing — Degree Requirements for City Positions

FOR the purpose of inviting the City Solicitor, the City Administrator, the Director of the Baltimore City Department of Human Resources, the Baltimore City Labor Commissioner, and the Director of the Mayor's Office of Employment Development to brief the City Council regarding the practice of requiring certain degrees for certain City positions and to discuss if eliminating such a degree requirement would be detrimental or beneficial to the recruitment and retention of quality City employees.

WHEREAS, possession of a degree from an institution of higher education does not necessarily correlate to higher pay for a graduate.

WHEREAS, many individuals who have attended an institution of higher education have amassed student loan debt and are unable to recover financially due to low wages paid for positions requiring a degree from an institution of higher education.

WHEREAS, career programs, apprenticeships, and employment experience can duly prepare individuals to succeed in the workforce.

WHEREAS, Baltimore City has experienced difficulty in retaining certain employees with a degree from an institution of higher education.

WHEREAS, certain functions of many positions are entry-level and do not require skills conferred from a degree from an institution of higher education.

WHEREAS, the elimination of certain degree requirements may help to decrease turnover of City employees.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, that the Baltimore City Council invites the City Solicitor, the City Administrator, the Director of the Baltimore City Department of Human Resources, the Baltimore City Labor Commissioner, and the Director of the Mayor's Office of Employment Development to brief the City Council regarding the practice of requiring certain degrees for certain City positions and to discuss if eliminating such a degree requirement would be detrimental or beneficial to the recruitment and retention of quality City employees.

AND BE IT FURTHER RESOLVED, that a copy of this Resolution be sent to the City Solicitor, the City Administrator, the Baltimore City Department of Human Resources, the Baltimore City Department of Labor Baltimore City Labor Commissioner, the Mayor's Office of Employment Development, and the Mayor's Legislative Liaison to the City Council.

BILL NO. 22-0100R REPORTED FAVORABLY AND ADOPTED

Councilmember Costello, for the Ways and Means Committee, reported Bill No. 22-0100R favorably.

Informational Hearing – Judicial In Rem Foreclosure

FOR the purpose of inviting the Commissioner of the Department of Housing and Community Development, the Deputy City Solicitor, and other relevant parties to come before the City Council to describe the in rem foreclosure process, inform the Council on the capacity of the Department of Housing and Community Development to increase in rem foreclosure cases, inform the Council on the role of the Circuit Court in the in rem foreclosure process, and recommend measures the City Council can take to support these efforts.

Recitals

In 2016, the Center for Community Progress authored a report about the Baltimore City tax sale system and suggested a number of reforms, including the implementation of the judicial in rem tax foreclosure process.

In 2019, Maryland Senate Bill 509/House Bill 557, sponsored by Senator Eckardt of Dorchester County and Delegate Holmes of Prince George's County, passed the General Assembly, enabling jurisdictions to use in rem foreclosure to acquire vacant and abandoned

properties. This was one of the actions recommended by the Tax Sale Task Force study that was completed in 2017.

In 2020, the Baltimore City Council passed Council Bill 20-0529, which established the in rem tax foreclosure process in Baltimore City.

In rem tax foreclosure allows the City to remove an abandoned property with liens that exceed the value of the property from tax sale and then foreclose on the liens. The City then takes title of the property and can utilize it for community development purposes in collaboration with the community. It is the best tool the City has to eliminate blight through rehabilitation or demolition of properties, while also controlling the outcome of the process.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the Baltimore City Council invites the Commissioner of the Department of Housing and Community Development, the Deputy City Solicitor, and other relevant parties to come before the City Council to describe the in rem foreclosure process, inform the Council on the capacity of the Department of Housing and Community Development to increase in rem foreclosure cases, inform the Council on the role of the Circuit Court in the in rem foreclosure process, and recommend measures the City Council can take to support these efforts.
