CITY OF BALTIMORE COUNCIL BILL

A BILL ENTITLED

AN ORDINANCE concerning Minors - Daytime Curfew

FOR the purpose of modifying the start of the daytime curfew for certain minors required to be in school; and generally relating to the related obligations of minors, of parents, guardians, etc., and of business establishments. BY repealing and reordaining, with amendments

Article 19 - Police Ordinances Section(s) 34-4(a), 34-5(b), and 34-6(b) Baltimore City Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 19. Police Ordinances

Subtitle 34. Minors - Daytime and Nighttime Curfews

§ 344. Prohibited conduct of minors - daytime curfew.

(a) In general.

Except as otherwise provided in subsection (b) of this section, no minor under the age of 16 may remain in or about any public place or any establishment between the hours of [9 a.m.] 7:30 A.M. and 2:30 p.m. on any day during which the minor is required to be in school.

§ 345. Prohibited conduct of parents, guardians, etc.

(b) Daytime curfew.

It is unlawful for the parent of any minor under the age16 to knowingly permit or, by insufficient control, to allow that minor to be in or about any public place or any establishment between the hours of [9 a.m.] 7:30 A.M. and 2:30 p.m. on any day during which the minor is required to be in school.

§ 346. Prohibited conduct of establishments.

(b) Daytime curfew.

No operator of an establishment or his agents or employees may knowingly permit any minor under the age of 16 to remain on the premises of that establishment between the hours of [9 a.m.] 7:30 A.M. and 2:30 p.m. on any school day, unless:

- (1) the minor has written proof from school authorities excusing his or her attendance at that particular time; or
- (2) the minor is accompanied by the minor's parent or by a person 21 years old or older.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
