SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

\$0.030 per cubic

Minimum \$300

All others \$0.075 per cubic

Accessory structures \$50 each

MAXIMUM \$5,000 PER STRUCTURE

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
