**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the Laws of Baltimore  
City read as follows:

**Baltimore City Code**

**Article 6. Historical and Architectural Preservation**

**Subtitle 17A. Landmark List: Exteriors - 2010s**

**§ 17A-44. Our Saviour Lutheran Church.**

Our Saviour Lutheran Church, 3301 The Alameda.

**Section 2. And be it further ordained,** That the catchlines contained in this Ordinance are not law and  
may not be considered to have been enacted as a part of this or any prior Ordinance.

**Section 3. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is  
enacted.
