By adding

Article 6 - Historical and Architectural Preservation  
Sections 18A-3  
Baltimore City Code  
(Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the Laws of Baltimore City read as follows:

#### **Baltimore City Code**

#### **Article 6. Historical and Architectural Preservation**

#### **Subtitle 18A. Landmark List: Exteriors - 2020s**

#### **§ 18A-3. Baltimore City Engine Company 14 Firehouse**

Baltimore City Engine Company 14 Firehouse, 1908 Hollins Street (Block 0207, Lot 005).

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
