FOR the purpose of designating the Roland Park Water Tower, 4210 Roland Avenue, as a historical landmark.

Article 6 - Historical and Architectural Preservation

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 12. Landmark List - 2000s

§ 12-26. ROLAND PARK WATER TOWER.

ROLAND PARK WATER TOWER, 4210 ROLAND AVENUE.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
