Article - Zoning Section(s) 10-405(25)(i) Baltimore City Revised Code

(Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Revised Code

Article - Zoning

§ 10405. Schedule of required spaces.

Offstreet parking spaces must be provided as follows:

- (25) Religious institutions.
- (i) Churches, temples, and synagogues

OR4, B41, B42,

B51, B52

No requirement

R9, R10, OR2,

OR3, B23, B33

1 per [20] 10 seats

All other districts

For a religious institution whose

worshipers are required to walk to worship because of religious

tenet

1 per [8] 4 seats

For all other facilities 1 per [4] 2 seats

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
