AN ORDINANCE concerning

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That Zoning Article § 1-153.1 {"Live entertainment"} is renumbered to be Zoning Article § 1-153.2 {"Live entertainment"}.

SECTION 2. AND BE IT FURTHER ORDAINED, That the Laws of Baltimore City read as follows:

Baltimore City Revised Code

Article - Zoning

§ 1-153.1. LIQUOR STORE: PACKAGE GOODS.

"LIQUOR STORE: PACKAGE GOODS" MEANS ANY ESTABLISHMENT THAT IS LICENSED TO SELL ALCOHOLIC BEVERAGES TO THE PUBLIC FOR OFF-PREMISES CONSUMPTION.

In a B2 District, permitted uses are as follows:

[(45) Liquor stores: package goods.]
§ 6309. Conditional uses - Ordinance required.
In a B21District, conditional uses that require approval by ordinance are as follows:
(9A) LIQUOR STORES: PACKAGE GOODS.
§ 6406. Permitted uses.
In a B3 District, permitted uses are as follows:
(1) As in a B2 District, except that business establishments are not limited to primarily retail or service establishments.
§ 6409. Conditional uses - Ordinance required.
In a B31District, conditional uses that require approval by ordinance are as follows:
(1) As in a B2 District (unless it is a permitted use under § 6406)
§ 6506. Permitted uses.
In a B4 District, permitted uses are as follows:
(1) As in a B2 District, except that business establishments are not limited to primarily retail or service establishments.
§ 6509. Conditional uses - Ordinance required.
In a B41District, conditional uses that require approval by ordinance are as follows:
(1) As in a B□District (unless it is a permitted use under § 6506)
(4A) LIQUOR STORES: PACKAGE GOODS.

§ 6606. Permitted uses.

In a B5 District, permitted uses are as follows:

(1) As in a B3 or B4 District.

§ 6609. Conditional uses - Ordinance required.

In a B5 District, conditional uses that require approval by ordinance are as follows:

(1) As in a B4 District (unless it is a permitted use under § 6606).

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
