SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the clubhouse at Forest Park Golf Course, located near the southeast corner of Block 8393, Lot 008, 120 feet north of the intersection of Forest Park Avenue and Hillsdale Road, is named the Rawlings-Fulton Clubhouse.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
