A BILL ENTITLED

AN ORDINANCE concerning

Baltimore City Landmark List - Franklin-Delphey Hotel

FOR the purpose of designating Franklin-Delphey Hotel, 300 West Franklin Street, as a historical landmark.

BY adding

Article 6 - Historical and Architectural Preservation Section(s) 13-1, to be under the new subtitle "Subtitle 13. Landmark List - 2010s" Baltimore City Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

SUBTITLE 13. LANDMARK LIST - 2010S

§ 13-1. FRANKLIN-DELPHEY HOTEL.

FRANKLIN-DELPHEY HOTEL, 300 WEST FRANKLIN STREET.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
