SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Article 6. Historical and Architectural Preservation

Subtitle 13. Landmark List - 2010s

§ 13-20. MONUMENTAL LODGE NO. 3, IMPROVED BENEVOLENT PROTECTIVE ORDER OF ELKS OF THE WORLD.

MONUMENTAL LODGE NO. 3, IMPROVED BENEVOLENT PROTECTIVE ORDER OF ELKS OF THE WORLD, 1528 MADISON AVENUE.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
