**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the name of Oliver Community Center Playground, located at 1400 East Oliver Street, is changed to Calvin B. Scruggs, Sr. Playground.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
