An Ordinance concerning

Rezoning - 1302 Key Highway

For the purpose of changing the zoning for the property known as 1302 Key Highway (Block 1927A, Lot 034A), as outlined in red on the accompanying plat, from the C-2 Zoning District to the OR-2 Zoning District.

By amending

Article - Zoning

Section 1. Be it Ordained by the Mayor and City Council of Baltimore, That Sheet 66 of the Zoning District Maps is amended by changing from the C-2 Zoning District to the OR-2 Zoning District the property known as 1302 Key Highway (Block 1927A, Lot 034A), as outlined in red on the plat accompanying this Ordinance.

Section 2. And be it further ordained, That as evidence of the authenticity of the accompanying plat and in order to give notice to the agencies that administer the City Zoning Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of Housing and Community Development, the Supervisor of Assessments for Baltimore City, and the Zoning Administrator.

Section 3. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
