SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 23. Sanitation

SUBTITLE 5. "DUMPSTERS" AND SIMILAR CONTAINERS

§ 5-1. DEFINITIONS.

(A) IN GENERAL.

IN THIS SUBTITLE, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

(B) DIRECTOR.

"DIRECTOR" MEANS THE DIRECTOR OF PUBLIC WORKS OR THE DIRECTOR'S DESIGNEE.

(C) DUMPSTER.

"DUMPSTER" MEANS ANY CONTAINER THAT:

(1) IS USED OR DESIGNED TO BE USED FOR SOLID WASTE COLLECTION OR STORAGE; AND

- (2) HAS A VOLUME OF AT LEAST 90 GALLONS OR ½ CUBIC YARD.
 - (D) PERSON.
- (1) "PERSON" MEANS:
- (I) AN INDIVIDUAL;
- (II) A PARTNERSHIP, FIRM, ASSOCIATION, CORPORATION, OR OTHER ENTITY OF ANY KIND; OR
- (III) A RECEIVER, TRUSTEE, GUARDIAN, PERSONAL REPRESENTATIVE, FIDUCIARY, OR REPRESENTATIVE OF ANY KIND.
- (2) "PERSON" DOES NOT INCLUDE A GOVERNMENTAL ENTITY OR AN INSTRUMENTALITY OR UNIT OF A GOVERNMENTAL ENTITY.
 - (E) SOLID WASTE.

"SOLID WASTE" MEANS:

- (1) ANY GARBAGE OR MIXED REFUSE, AS THOSE TERMS ARE DEFINE IN § 2-1 OF THIS ARTICLE; AND
- (2) ANY OTHER SOLID WASTE, AS THAT TERM IS DEFINED IN CITY HEALTH ARTICLE § 7-101.
- § 5-2. RULES AND REGULATIONS.
 - (A) DIRECTOR MAY ADOPT.

THE DIRECTOR MAY ADOPT AND ENFORCE RULES AND REGULATIONS TO CARRY OUT THIS SUBTITLE.

(B) FILING WITH LEGISLATIVE REFERENCE.

A COPY OF ALL RULES AND REGULATIONS MUST BE FILED WITH THE DEPARTMENT OF LEGISLATIVE REFERENCE BEFORE THEY TAKE EFFECT.

- §§ 5-3 TO 5-5. {RESERVED}
- § 5-6. REGISTRATION REQUIRED.
- (A) IN GENERAL.

THE OWNER OF ANY DUMPSTER TO BE USED IN THE CITY MUST FIRST REGISTER THE DUMPSTER WITH THE DIRECTOR.

- (B) APPLICATION.
- (1) THE REGISTRATION MUST BE MADE IN THE FORM THAT THE DIRECTOR REQUIRES.

- (2) IN ADDITION TO ANY OTHER INFORMATION THAT THE DIRECTOR REQUIRES, THE REGISTRATION MUST INCLUDE:
- (I) THE NAME, ADDRESS, AND TELEPHONE NUMBER OF THE OWNER;
- (II) THE NAME, ADDRESS, AND TELEPHONE NUMBER OF ANY LESSEE OR OTHER PERSON WHO POSSESSES THE DUMPSTER; AND
 - (III) A DESCRIPTION OF THE DUMPSTER.
 - (C) SUPPLEMENTAL INFORMATION.

THE OWNER MUST REPORT TO THE DIRECTOR, WITHIN 30 DAYS OF THE EVENT:

- (1) ANY NEWLY ACQUIRED DUMPSTER;
- (2) THE TRANSFER OF OWNERSHIP, POSSESSION, OR LOCATION OF ANY REGISTERED DUMPSTER; AND
- (3) ANY OTHER CHANGE IN THE REGISTRATION INFORMATION PROVIDED.
- § 5-7. TERM AND RENEWAL.
 - (A) TERM.

EACH REGISTRATION FILED UNDER THIS SUBTITLE EXPIRES ANNUALLY ON DECEMBER 31, UNLESS RENEWED.

(B) RENEWAL.

THE APPLICATION FOR RENEWAL OF A REGISTRATION MUST BE MADE IN THE FORM THAT THE DIRECTOR REQUIRES.

- § 5-8. FEES.
 - (A) IN GENERAL.
- (1) THE AMOUNT OF THE ANNUAL FEE FOR REGISTRATION IS AS SET FROM TIME TO TIME BY THE DIRECTOR, WITH THE APPROVAL OF THE BOARD OF ESTIMATES.
- (2) THE FEE SO SET MAY INCLUDE AN APPROPRIATE DIFFERENTIAL BASED ON SIZE AND MATERIAL..
 - (B) FEE FOR LESS THAN FULL YEAR.

THE ANNUAL FEE FOR LESS THAN A FULL INITIAL YEAR IS PRORATED QUARTERLY.

(C) FEES NOT REFUNDABLE.

NO REFUNDS, IN WHOLE OR IN PART, MAY BE MADE OF ANY REGISTRATION FEES REQUIRED BY THIS SUBTITLE.

§§ 5-9 TO 5-10. {RESERVED}

- § 5-11. MARKINGS ON DUMPSTER.
- (A) REQUIRED DISPLAYS.

EACH DUMPSTER MUST DISPLAY, AT ALL TIMES:

- (1) A CURRENT REGISTRATION MEDALLION ISSUED BY THE DIRECTOR; AND
- (2) ON A SIDE EXPOSED TO PUBLIC VIEW, IN LETTERING AT LEAST 3" HIGH, THE NAME, ADDRESS, AND TELEPHONE NUMBER OF ITS OWNER.
 - (B) ADVERTISING PROHIBITED.

EXCEPT AS REQUIRED BY SUBSECTION (A) OF THIS SECTION OR AS OTHERWISE AUTHORIZED BY A RULE OR REGULATION ADOPTED UNDER THIS SUBTITLE, NO ADVERTISING MAY APPEAR ON A DUMPSTER.

§ 5-12. USING UNREGISTERED DUMPSTER.

NO PERSON MAY USE ANY DUMPSTER THAT:

- (1) HAS NOT BEEN REGISTERED UNDER THIS SUBTITLE; OR
- (2) DOES NOT DISPLAY THE MEDALLION AND OTHER INFORMATION REQUIRED BY THIS SUBTITLE.
- § 5-13. PLACEMENT IN RIGHT-OF-WAY.

NO PERSON MAY PLACE ANY DUMPSTER ON A STREET, SIDEWALK, OR OTHER PUBLIC RIGHT-OF-WAY EXCEPT:

- (1) MOMENTARILY, AS NECESSARY WHILE THE DUMPSTER IS BEING EMPTIED; OR
- (2) IN STRICT ACCORDANCE WITH A MINOR PRIVILEGE PERMIT ISSUED FOR THAT PURPOSE, THE TERMS OF WHICH ARE PROMINENTLY DISPLAYED ON THE DUMPSTER IN THE MANNER THAT THE DIRECTOR SPECIFIES.
- §§ 5-14 TO 5-15. {RESERVED}
- § 5-16. IMPOUNDING DUMPSTERS IN VIOLATION.
 - (A) IN GENERAL.

FOR ANY DUMPSTER FOUND TO BE UNREGISTERED, OR IN A PUBLIC RIGHT-OF-WAY WITHOUT OR IN VIOLATION OF A MINOR PRIVILEGE PERMIT, OR OTHERWISE IN VIOLATION OF THIS SUBTITLE,

THE DIRECTOR MAY:

- (1) CAUSE THE DUMPSTER TO BE SUMMARILY TOWED TO AND IMPOUNDED AT SOME SUITABLE STORAGE AREA; OR
- (2) SEND WRITTEN NOTICE THE PERSONS THOUGHT TO BE RESPONSIBLE, ORDERING THE DUMPSTER'S REMOVAL WITHIN THE TIME SPECIFIED IN THE NOTICE.
 - (B) COSTS AND EXPENSES.
- (1) ANY PERSON WHO USES OR PLACES A DUMPSTER IN VIOLATION OF THIS SUBTITLE IS LIABLE TO THE CITY FOR THE COSTS OF ITS TOWING AND STORING UNDER THIS SECTION.
- (2) THESE COSTS ARE AS SET BY THE DIRECTOR FROM TIME TO TIME, WITH THE APPROVAL OF THE BOARD OF ESTIMATES.
- § 5-17. ENFORCEMENT BY CITATION.
 - (A) IN GENERAL.

IN ADDITION TO ANY OTHER CIVIL OR CRIMINAL REMEDY OR ENFORCEMENT PROCEDURE, THIS SUBTITLE MAY BE ENFORCED BY ISSUANCE OF:

- (1) AN ENVIRONMENTAL CITATION UNDER CITY CODE ARTICLE 1, SUBTITLE 40 {"ENVIRONMENTAL CONTROL BOARD"}; OR
- (2) A CIVIL CITATION UNDER CITY CODE ARTICLE 1, SUBTITLE 41 {"CIVIL CITATIONS"}.
- (B) PROCESS NOT EXCLUSIVE.

THE ISSUANCE OF A CITATION TO ENFORCE THIS SUBTITLE DOES NOT PRECLUDE PURSUING ANY OTHER CIVIL OR CRIMINAL REMEDY OR ENFORCEMENT ACTION AUTHORIZED BY LAW.

- § 5-18. PENALTIES.
 - (A) IN GENERAL.

ANY PERSON WHO VIOLATES ANY PROVISION OF THIS SUBTITLE OR OF A RULE OR REGULATION ADOPTED UNDER THIS SUBTITLE IS GUILTY OF A MISDEMEANOR AND, ON CONVICTION, IS SUBJECT TO A FINE OF NOT MORE THAN \$1,000 FOR EACH OFFENSE.

(B) EACH DAY A SEPARATE OFFENSE.

EACH DAY THAT A VIOLATION CONTINUES IS A SEPARATE OFFENSE.
