SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Mayor and City Council of Baltimore consents to and approves the petition to extend the Metropolitan District of Baltimore County to a tract of land, consisting of approximately 3.329 acres, located in the 4C4 Election District of Baltimore County in the vicinity of 7 Church Road, on the west side of Church Road, as more particularly shown on the plat labeled Extension 157 and filed with the Department of Public Works of Baltimore County.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
