AN ORDINANCE concerning

Baltimore City Landmark List - Parkway Theatre

FOR the purpose of designating the Parkway Theatre, 3 West North Avenue, as a historical landmark.

BY adding

Article 6 - Historical and Architectural Preservation Section(s) 13-20 Baltimore City Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 13. Landmark List - 2010s

§ 13-20. PARKWAY THEATRE.

PARKWAY THEATRE, 3 WEST NORTH AVENUE.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
