AN ORDINANCE concerning

Zoning - Conditional Use - Amending Ordinance 14-206

FOR the purpose of amending Ordinance 14-206 to reauthorize and continue the permission for the establishment, maintenance, and operation of a parking, open-off street area for the parking of 4 or more automobiles on the property known as 4001 Roland Avenue; providing for the automatic termination of this Ordinance; and providing for a special effective date.

BY repealing and reordaining, with amendments Ordinance 14-206 Section(s) 2

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Ordinance 14-206

SECTION 2. AND BE IT FURTHER ORDAINED, That the permission granted by this Ordinance applies [for 2 years from the date that this Ordinance becomes effective] THROUGH APRIL 19, 2018; and[, at the end of that period], AFTER THAT DATE with no further action by the Mayor and City Council, this permission will be abrogated and of no further effect.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on April 19, 2016.
