A BILL ENTITLED

AN ORDINANCE concerning
Health - Smoking On or Adjacent to Hospital Premises

FOR the purpose of prohibiting smoking on or adjacent to hospital premises; defining certain terms; providing for certain exceptions; imposing certain penalties; providing for a special effective date; and generally relating to smoking in areas near hospitals.

Article - Health

Section(s) 12-601 through 12-612, inclusive, to be under the new subtitle

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Revised Code

Article - Health

Title 12. Tobacco Products

SUBTITLE 6. SMOKING ON OR ADJACENT TO HOSPITAL PREMISES

§ 12-601. DEFINITIONS.

(A) IN GENERAL.

IN THIS SUBTITLE, THE FOLLOWING TERMS HAVE THE MEANINGS INDICATED.

(B) HOSPITAL.

“HOSPITAL” MEANS AN INSTITUTION THAT:

- (1) HAS A GROUP OF AT LEAST 5 PHYSICIANS WHO ARE ORGANIZED AS A MEDICAL STAFF FOR THE INSTITUTION;
- (2) MAINTAINS FACILITIES TO PROVIDE, UNDER THE SUPERVISION OF THE MEDICAL STAFF,

DIAGNOSTIC AND TREATMENT SERVICES FOR 2 OR MORE UNRELATED INDIVIDUALS; AND

- (3) ADMITS OR RETAINS THE INDIVIDUALS FOR OVERNIGHT CARE.
(C) SMOKE.

“SMOKE” MEANS TO INHALE, BURN, OR CARRY ANY LIGHTED CIGARETTE, CIGAR, PIPE TOBACCO, OR OTHER TOBACCO, WEED, OR PLANT PRODUCT OF ANY KIND.

§ 12-602. {RESERVED}

§ 12-603. SMOKING PROHIBITED.

EXCEPT AS OTHERWISE SPECIFIED IN THIS SUBTITLE, SMOKING IS PROHIBITED:

- (1) ON THE PREMISES OF ANY HOSPITAL; AND
- (2) ON ANY PUBLIC RIGHT-OF-WAY (INCLUDING SIDEWALKS, ALLEYS, AND THEIR SURROUNDING GRASS, TREE, OR OTHER PLANTED AREAS) ADJOINING THE PREMISES OF A HOSPITAL AND EXTENDING TO THE CLOSEST CURB LINE.

§ 12-604. EXCEPTION.

THIS SUBTITLE DOES NOT APPLY TO A PERSON WHO OCCUPIES A MOVING VEHICLE IN AN ALLEY.

§ 12-605. “NO SMOKING” SIGNS.

- (A) HOSPITALS TO POST.

EVERY HOSPITAL MUST “NO SMOKING” SIGNS, “SMOKE FREE AREA” SIGNS, OR THE INTERNATIONAL NO-SMOKING SYMBOL (A BURNING CIGARETTE ENCLOSED IN A RED CIRCLE WITH A RED ACROSS IT) IN CONSPICUOUS PLACES ON ITS PREMISES SUFFICIENT TO PROVIDE PUBLIC NOTICE OF THE SMOKING PROHIBITION.

- (B) FAILURE TO POST.

THE FAILURE OF A HOSPITAL TO POST THESE SIGNS:

- (1) IS NOT PUNISHABLE UNDER THIS SUBTITLE; AND
- (2) IS NOT A DEFENSE TO SMOKING IN VIOLATION OF THIS SUBTITLE.

§§ 12-606 TO 12-610. {RESERVED}

§ 12611. ENFORCEMENT BY CITATION.

- (A) IN GENERAL.

IN ADDITION TO ANY OTHER CIVIL OR CRIMINAL REMEDY OR ENFORCEMENT PROCEDURE, THIS SUBTITLE MAY BE ENFORCED BY ISSUANCE OF:

(1) AN ENVIRONMENTAL CITATION AS AUTHORIZED BY CITY CODE ARTICLE 1, SUBTITLE 40 {"ENVIRONMENTAL CONTROL BOARD"}; OR

(2) A CIVIL CITATION AS AUTHORIZED BY CITY CODE ARTICLE 1, SUBTITLE 41 {"CIVIL CITATIONS"}

(B) PROCESS NOT EXCLUSIVE.

THE ISSUANCE OF A CITATION TO ENFORCE THIS SUBTITLE DOES NOT PRECLUDE PURSUING ANY OTHER CIVIL OR CRIMINAL REMEDY OR ENFORCEMENT ACTION AUTHORIZED BY LAW.

§ 12612. PENALTIES.

ANY PERSON WHO SMOKES IN VIOLATION OF THIS SUBTITLE IS SUBJECT TO A CIVIL FINE OF NOT MORE THAN \$50 FOR EACH OFFENSE.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
