An Ordinance concerning

**City Streets - Renaming Cromwell Street to Vision Street**

For the purpose of changing the name of Cromwell Street, between Clarkson Street and McComas Street, to Vision Street.

Article 26 - Surveys, Streets, and Highways  
Section 7-3  
Baltimore City Code  
(Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the name of Cromwell Street, between Clarkson Street and McComas Street, is changed to Vision Street.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
