BY repealing
Ordinance 08-10

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That Ordinance 08-10, approved May 12, 2008, is repealed, and the authority conferred in that Ordinance to designate the Gateway South Planned Unit Development is rescinded.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
