**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the Laws of Baltimore City read as follows:

**Subtitle 18A. Landmark List: Exteriors - 2020s**

**§ 18A-2. Truck House No. 5. (Oliver Community Firehouse)**

Truck House No. 5 (Oliver Community Firehouse), 1220 E. Oliver St.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
