A BILL ENTITLED

AN ORDINANCE concerning

Supplementary Federal Appropriation - Department of General Services - \$100,000

FOR the purpose of providing a Supplementary Federal Appropriation in the amount of \$100,000 to the Department of General Services - Program #9916, to provide funding to install solar energy systems on selected City buildings; and providing for a special effective date.

Recitals

The revenue appropriated by this Ordinance represents a grant from Federal Revenue administered through the Maryland Energy Administration in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2011.

That grant could not have been expected with reasonable certainty when the Ordinance of Estimates for Fiscal Year 2011 was formulated.

On December 15, 2010, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$100,000 shall be made available to the Department of General Services - Program #9916 as a Supplementary Federal Appropriation for Fiscal Year 2011, to provide funding to install solar energy systems on selected City buildings. The source of revenue for this appropriation is the grant from Federal Revenue administered through the Maryland Energy Administration in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2011.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
