SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 5. Finance, Property, and Procurement

Subtitle 25. Hours and Wages - Construction Contracts

§ 2511. Required records - Delinquencies.

(b) Fines.

[(1)] In addition, if the contractor is delinquent in submitting [his or any of the subcontractors' payrolls] ANY PAYROLL, the contractor shall forfeit and pay to the City a penalty [in the amount] of \$10 for each calendar day that the [weekly] payroll is late.

[(2)] A weekly payroll shall mean the combined payrolls of the contractor and all of his subcontractors in any 1 work week.]

Subtitle 26. Hours and Wages - Service Contracts

§ 2611. Required records - Delinquencies.

(b) Fines.

[(1)] In addition, if the contractor is delinquent in submitting [payrolls] ANY PAYROLL, the [service] contractor

shall forfeit and pay to the City a penalty [in the amount] of \$10 for each calendar day that the payroll is late.

[(2) A payroll shall mean the combined payrolls of the contractor and all subcontractors in any 1 pay period.]

Article 11. Labor and Employment

Division I. Minimum Wage Law

Subtitle 6. Penalties and Fines

§ 621. Fines.

Any employer or employee who violates this Division I shall forfeit and pay to the City of Baltimore a penalty [in the amount of] AS FOLLOWS:

- (1) FOR A 1ST OFFENSE, [\$50] \$250 for each violation [for a 1st offense];
- (2) FOR A 2ND OFFENSE, [\$250] \$500 for each violation [for a 2nd offense]; and
- (3) FOR EACH SUBSEQUENT OFFENSE, [\$500] \$1,000 for each violation [thereafter].

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
