**Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That Ordinance 04-887, which established the Uplands Renewal Area and Plan, as amended by Ordinance 08-99, is repealed.

Section 2. And be it further ordained, That this Ordinance takes effect on the date it is enacted.
