**Urban Renewal - Poppleton - Amendment** \_\_\_\_\_

For the purpose of amending the Urban Renewal Plan for Poppleton to reauthorize the acquisition of properties within the Project Area, to extend the life of the Plan, and to remove certain properties from the list in Appendices A and C; waiving certain content and procedural requirements; making the provisions of this Ordinance severable; providing for the application of this Ordinance in conjunction with certain other ordinances; and providing for a special effective date.

**Recitals**

The Urban Renewal Plan for Poppleton was originally approved by the Mayor and City Council of Baltimore by Ordinance 75-837 and last amended by Ordinance 19-294.

An amendment to the Urban Renewal Plan for Poppleton is necessary to reauthorize the Plan's powers of acquisition and condemnation so that these actions may legally continue, in compliance with § 12-105.1 of the Real Property Article of the Annotated Code of Maryland, to extend the life of the Plan, and to remove certain properties from the lists in Appendices A and C.

Under Article 13, § 2-6 of the Baltimore City Code, no change may be made in any approved renewal plan unless the change is approved in the same manner as that required for the approval of a renewal plan.

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the following changes in the Urban Renewal Plan for Poppleton are approved:

(1) In the Plan, amend C.1.d. to read as follows:

C. TECHNIQUES USED TO ACHIEVE PLAN OBJECTIVES

1. Acquisition

....

- d. The authority to acquire the Properties within the Project Area is expressly confirmed and reauthorized through and including [December 31, 2022] December 31, 2026.

- (2) In the Plan, amend D. To read as follows:

D. DURATION OF PROVISIONS AND REQUIREMENTS

The Poppleton Urban Renewal Plan, as [it may be] amended from time to time, [shall remain] is in full force and effect [for a period of 50 years from the date of original adoption of this Renewal Plan by ordinance of the Mayor and City Council of Baltimore] through and including December 31, 2026.

**Section 2. And be it further ordained,** That the Urban Renewal Plan for Poppleton, as amended by this Ordinance and identified as “Urban Renewal Plan, Poppleton, revised to include Amendment \_\_\_\_, dated September 19, 2022”, is approved. The Department of Planning shall file a copy of the amended Urban Renewal Plan with the Department of Legislative Reference as a permanent public record, available for public inspection and information.

**Section 3. And be it further ordained,** That if the amended Urban Renewal Plan approved by this Ordinance in any way fails to meet the statutory requirements for the content of a renewal plan or for the procedures for the preparation, adoption, and approval of a renewal plan, those requirements are waived and the amended Urban Renewal Plan approved by this Ordinance is exempted from them.

**Section 4. And be it further ordained,** That if any provision of this Ordinance or the application of this Ordinance to any person or circumstance is held invalid for any reason, the invalidity does not affect any other provision or any other application of this Ordinance, and for this purpose the provisions of this Ordinance are declared severable.

**Section 5. And be it further ordained,** That if a provision of this Ordinance concerns the same subject as a provision of any zoning, building, electrical, plumbing, health, fire, or safety law or regulation, the applicable provisions shall be construed to give effect to each. However, if the provisions are found to be in irreconcilable conflict, the one that establishes the higher standard for the protection of the public health and safety prevails. If a provision of this Ordinance is found to be in conflict with an existing provision of any other law or regulation that establishes a lower standard for the protection of the public health and safety, the provision of this Ordinance prevails and the other conflicting provision is repealed to the extent of the conflict.

**Section 6. And be it further ordained,** That this Ordinance takes effect on the date it is enacted.
