Title:	Fire and Police Employees' Retirement System - Benefits						
	FOR the purpose of modifying certain Fire and Police Employees' Retirement System interest rate assumptions; changing the definition of "average final compensation" for all System members who not meet certain conditions; clarifying the definition of "earnable compensation;" making the Director of Finance an ex-officio member of the Board of Trustees of the System; allowing the Director of Finance to authorize a designated representative to act in his or her stead at board meetings; addin 1 additional Board of Trustees appointee, appointed from a list of recommended candidates submit by the President of the City Council, to the existing 2 City resident mayoral appointees; establishing new qualifications for the mayoral appointees; exempting the Board of Trustees from the City Chart provision requiring minority party representation on City boards; changing the age and service requirements for the normal service retirement benefit for all System members who do not meet certain conditions; establishing a new early service retirement benefit for System members who do not qualify for normal service retirement; increasing the percentage of compensation contributable to System members; amending provisions of the System law pertaining to post-retirement increases be discontinuing the variable benefit increase and substituting a fixed percentage increase; discontinui the utilization of certain existing System accounting reserves; clarifying the existing DROP 2 eligibilit provisions for System members who do not meet certain conditions; establishing a minimum benefit for certain retirees and beneficiaries; providing for special effective date; and generally relating to the Fire and Police Employees' Retirement System the City of Baltimore.
