CITY OF BALTIMORE COUNCIL BILL

A BILL ENTITLED

AN ORDINANCE concerning

Supplementary Motor Vehicle Fund Operating Appropriation - Department of Transportation - \$3,200,000

FOR the purpose of providing a Supplementary Motor Vehicle Fund Operating Appropriation in the amount of \$3,200,000 to the Department of Transportation - Service 684 (Traffic Management and Safety), to provide funding for additional operating expenses; and providing for a special effective date.

BY authority of Article VI - Board of Estimates Section 8(b)(3) and (c) Baltimore City Charter (1996 Edition)

Recitals

The revenue appropriated by this Ordinance represents funds from the Fiscal 2011 Speed Camera revenue in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2011.

This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2011 was formulated.

This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2011 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.

On May 25, 2011, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$3,200,000 shall be made available to the Department of Transportation - Service 684 (Traffic Management and Safety) as a Supplementary Motor Vehicle Fund Operating Appropriation for Fiscal Year 2011, to provide funding for additional

operating expenses. The source of revenue for this appropriation is from Speed Camera revenue (\$3,200,000) in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2011.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
