Sponsors:	FOR the purpose of authorizing the Mayor and City Council of Baltimore (pursuant to Resolution V of 2010 approved by the members of the Maryland General Assembly representing Baltimore City) to create a debt, and to issue and sell its certificates of indebtedness as evidence thereof, and proceeds not exceeding \$16,200,000 from the sale of such certificates of indebtedness to be used for the cost of issuance, including the expense of engraving, printing, advertising, attorneys' fees, and all other incidental expenses connected therewith, and the remainder of such proceeds to be used for the acquisition, by purchase, condemnation, or any other legal means, of land or property, or any rights therein, in the City of Baltimore, and for constructing and erecting, on said land or property, or on any land or property, new buildings, structures and other auxiliary facilities owned by the Mayor and City Council of Baltimore, and for the renovation, alternation, construction, reconstruction, installation, improvement and repair of existing buildings, structures and facilities to be or now being used in connection with the operations, and functions of buildings of the Mayor and City Council of Baltimore; and for the renovation developed in connection with the operations, and functions of buildings, but not limited to, the costs and expenses of securing administrative, appraisal, economic analysis, engineering, planning, designing, architectural, surveying, and other professional services; and for doing any and all things necessary, proper or expedient in connection with or pertaining to any or all of the matters or things hereinbefore mentioned; authorizing the issuance of refunding bonds; conferring and imposing upon the Board of Finance of Baltimore City or Baltimore, for their approval or disapproval, at the election to be held in Baltimore City ouncil of Baltimore, and by the municipal agency designated in the annual Ordinance of the Mayor and City Council of Baltimore, and by the municipal agency designated in the ann
