A BILL ENTITLED

AN ORDINANCE concerning
Supplementary Special Fund Operating Appropriation - Mayor's Office of Employment Development - \$69,617

FOR the purpose of providing a Supplementary Special Fund Operating Appropriation in the amount of \$69,617 to the Mayor's Office of Employment Development - Service 797 (Career Center Services), to provide funding for job readiness, remedial education, and occupational outcomes for target populations within the East Baltimore Development Pipeline; and providing for a special effective date.

Recitals

The revenue appropriated by this Ordinance represents a grant from the East Baltimore Development Incorporated in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2013.

That grant could not have been expected with reasonable certainty when the Ordinance of Estimates for Fiscal Year 2013 was formulated.

On February 27, 2013, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$69,617 shall be made available to the Mayor's Office of Employment Development - Service 797 (Career Center Services) as a Supplementary Special Fund Operating Appropriation for Fiscal Year 2013, to provide funding for job readiness, remedial education, and occupational outcomes for target populations within the East Baltimore Development Pipeline. The source of revenue for this appropriation is a grant from the East Baltimore Development

Incorporated in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2013.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
