A BILL ENTITLED

AN ORDINANCE concerning

Supplementary General Fund Capital Appropriation - Enoch Pratt Free Library - \$1,000,000

FOR the purpose of providing a Supplementary General Fund Capital Appropriation in the amount of \$1,000,000 to the Enoch Pratt Free Library (Account #9936-457-201), to provide funds for library branch capital needs; and providing for a special effective date.

Article VI - Board of Estimates

Section 8(b)(3) and (c)

Baltimore City Charter

Recitals

The revenue appropriated by this Ordinance represents funds from the Income Tax in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2006.

This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2006 was formulated.

This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2006 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.

On April 12, 2006, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$1,000,000 shall be made available to the Enoch Pratt Free Library (Account #9936-457-201) as a Supplementary General Fund Capital Appropriation for Fiscal Year 2006, to provide funds for library branch capital needs. The source of revenue for this appropriation is funds from the Income Tax in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2006.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
