AN ORDINANCE concerning Sale of Property - 251-253 South Ann Street (Block 1754, Lot 26)

FOR the purpose of authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain property known as 251-253 South Ann Street (Block 1754, Lot 26) and no longer needed for public use; and providing for a special effective date. SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That, in accordance with Article V, § 5(b) of the City Charter, the City Comptroller may sell, at either public or private sale, all the interest of the Mayor and City Council of Baltimore in the property known as 251-253 South Ann Street (Block 1754, Lot 26), and more particularly described as follows:
