A BILL ENTITLED

AN ORDINANCE concerning Indoor Smoking Ban - Conforming Effective Date

FOR the purpose of conforming the effective date of Ordinance 07-392 {"Health - Indoor Smoking"} to that of the State's Clean Indoor Act of 2007; and providing for a special effective date. BY repealing and reordaining Ordinance 07-392 Section 4

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Ordinance 07-392

SECTION 4. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on [January] FEBRUARY 1, 2008.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
