FOR the purpose of authorizing an economic development project to be known as "701 Aliceanna Street", in order that the Board of Estimates of Baltimore City (the "Board") may enter into a Payment in Lieu of Taxes Agreement with Harbor East Parcel D-Acquisition, LLC, its successors or assigns (the "Owner") covering a portion of the Owner's property, consisting of (i) office space consisting of

approximately 500,000 rentable square feet, and (ii) a structured parking facility containing

approximately 1,200 parking spaces and related improvements; generally relating to payments in lieu

of taxes for the 701 Aliceanna Street development; and providing for a special effective date.
