AN ORDINANCE concerning

Metropolitan District of Baltimore County - Extension 153

FOR the purpose of consenting to and approving a petition to extend the Metropolitan District of Baltimore County to a certain tract of land; and providing for a special effective date.

BY direction of

Article 3 - Baltimore County Section(s) 498 through 528 Code of Public Local Laws of Maryland (1955 Everstine Edition)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Mayor and City Council of Baltimore consents to and approves the petition to extend the Metropolitan District of Baltimore County to a tract of land, consisting of approximately 11.211 acres, located in the 4C4 Election District of Baltimore County in the vicinity of West Cherry Court, east of Franklin Boulevard and south of the Northwest Expressway (I-795), as more particularly shown on the plat labeled Extension 153 and filed with the Department of Public Works of Baltimore County.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
