FOR the purpose of amending the maximum bed capacity for the home for homeless persons on the property known as 1017 East Baltimore Street, as outlined in red on the accompanying plat.

BY repealing and reordaining, with amendments

Ordinance 02-422

Section(s) 1

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Ordinance 02-422

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That permission is granted for the establishment, maintenance, and operation of a home for homeless persons on the property known as 1017 East Baltimore Street, as outlined in red on the plat accompanying this Ordinance, in accordance with Zoning Code §§ 6-409(1) and 14-102 of the Baltimore City Code, subject to the following conditions:

1. The maximum number of beds is [50] 100, all of which must be used for the housing of homeless men who have successfully completed the Mission's Spiritual Recovery Program.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
