A BILL ENTITLED

AN ORDINANCE concerning

General Fund Operating Appropriation Transfer - M-R: Miscellaneous General Expenses (Program 122) to Fire Department (Program 602) - \$300,000

FOR the purpose of transferring a General Fund Operating Appropriation in the amount of \$300,000 from the M-R: Miscellaneous General Expenses (Program 122 - Miscellaneous General Expenses) to the Fire Department (Program 602 - Fire Suppression and Emergency Rescue); and providing for a special effective date.

BY authority of Article VI - Board of Estimates Section 9(a)(2) Baltimore City Charter (1996 Edition)

Recitals

Article VI, § 9(a)(2) of the City Charter provides that, on recommendation of the Board of Estimates, the City Council by ordinance may authorize the transfer of an appropriation contained in the Ordinance of Estimates from one municipal agency to another municipal agency.

The sum of \$300,000, as appropriated to the M-R: Miscellaneous General Expenses (Program 122 - Miscellaneous General Expenses) in the Fiscal 2013 Ordinance of Estimates, is not needed for the purpose for which it was appropriated and, therefore, is available for transfer to another agency.

On October 24, 2012, the Board of Estimates recommended the transfer authorized by this Ordinance.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the sum of \$300,000, contained in the Fiscal 2013 Ordinance of Estimates as a General Fund Operating Appropriation, is transferred from the M-R: Miscellaneous General Expenses (Program 122 - Miscellaneous General Expenses) to the Fire Department (Program 602 - Fire Suppression and Emergency Rescue).

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
