A BILL ENTITLED

AN ORDINANCE concerning

Supplementary General Fund Operating Appropriation - M-R: Mayor's Office of Human Services - \$218,623

FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$218,623 to the M-R: Mayor's Office of Human Services - Service 356 (Administration), to provide funding for additional operating expenses; and providing for a special effective date.

BY authority of Article VI - Board of Estimates Section 8(b)(2) and (c) Baltimore City Charter (1996 Edition)

Recitals

The revenue appropriated by this Ordinance represents funds from the State Race Track Grant in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2014.

That grant could not have been expected with reasonable certainty when the Ordinance of Estimates for Fiscal Year 2014 was formulated.

On October 16, 2013, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$218,623 shall be made available to the M-R: Mayor's Office of Human Services - Service 356 (Administration) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2014, to provide funding for additional operating expenses. The source of revenue for this appropriation is funds from the State Race Track Grant in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2014.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
