## A BILL ENTITLED

#### AN ORDINANCE concerning Tax Credits - Historic Restorations and Rehabilitations

FOR the purpose of extending the period within which applications may be accepted for the tax credit for historic restorations and rehabilitations; and providing for a special effective date.

BY repealing and reordaining, with amendments Article 28 - Taxes Section(s) 10-8(m) Baltimore City Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 28. Taxes

Subtitle 10. Credits

§ 108. Historic restorations and rehabilitations.

(m) Termination of program.

Applications for the credit may not be accepted after [February 28, 2014] FEBRUARY 29, 2016.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on February 28, 2014.
