Article 1 - Mayor, City Council, and Municipal Agencies Section(s) 23-4(b)(18)
Baltimore City Code

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 1. Mayor, City Council, and Municipal Agencies

Subtitle 23. Mayor's Commission on Disabilities

- § 23-4. Members; associates.
 - (b) Associates.

One representative from each of the following agencies serves as a non-voting associate:

. . . .

(18) OFFICE OF RISK MANAGEMENT.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
