AN ORDINANCE concerning

City Property - Renaming Robert E. Lee Park to Lake Roland Park

FOR the purpose of changing the name of the park known as Robert E. Lee Park, located in Baltimore County, to Lake Roland Park.

BY authority of
Article 5 - Finance, Property, and Procurement
Section 20-2
Baltimore City Code
(Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the name of the park known as Robert E. Lee Park, located in Baltimore County, is changed to Lake Roland Park.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
