AN ORDINANCE concerning

BY authority of Article 26 - Surveys, Streets, and Highways Section 7-3 Baltimore City Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That an unnamed alley, located between the 500 block of South Clinton Street and the 500 block of South Highland Avenue, as shown on Property Location Division Block Plat No. 6423, Ward 26, Lot 11, is named Harry Way.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect when it is enacted.
