## AN ORDINANCE concerning

Baltimore City Landmark List: Exteriors - American Legion Federal Post # 19

FOR the purpose of designating the American Legion Federal Post # 19, 1502 Madison Avenue, as an historical landmark: exterior.

BY adding

Article 6 - Historical and Architectural Preservation Section(s) 17A-35 Baltimore City Code (Edition 2000)

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:

**Baltimore City Code** 

Article 6. Historical and Architectural Preservation

Subtitle 17A. Landmark List: Exteriors ♦ 2010s

♦ 17A-35. AMERICAN LEGION FEDERAL POST # 19.

AMERICAN LEGION FEDERAL POST # 19, 1502 MADISON AVENUE.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day after the date it is enacted.
