AN ORDINANCE concerning
Repeal of Ordinance 02-299 - Flag House Court Hope VI Planned Unit Development
FOR the purpose of repealing Ordinance 02-299, which designated certain properties as a Residential Planned Unit Development known as Flag House Court Hope VI; and providing for a special effective date.

BY repealing
Ordinance 02-299

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That Ordinance 02-299 is repealed, and the authority conferred in that Ordinance to designate certain properties as a Residential Planned Unit Development known as Flag House Court Hope VI is rescinded.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect when it is enacted.
