SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the  
Laws of Baltimore City read as follows:

Subtitle 17A. Landmark List: Exteriors ♦ 2010s

♦ 17A-36. APOSTOLIC FAITH CHURCH OF GOD BUILDING.

APOSTOLIC FAITH CHURCH OF GOD BUILDING, 1939 WALBROOK AVENUE.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance  
are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30th day  
after the date it is enacted.
