AN ORDINANCE concerning  
**Street Encroachment - 201 North Schroeder Street**

FOR the purpose of permitting, subject to certain conditions, the construction and maintenance of a portion of a building projecting into the public right-of-way on the east side of North Schroeder Street, the north side of Lexington Street, and the west side of North Amity Street of the property known as 201 North Schroeder Street; and providing for a special effective date.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That:

- (a) Permission is granted for the construction and maintenance of a portion of a building located on the east side of North Schroeder Street and known as 201 North Schroeder Street, the portion of the building extending into the public right-of-way of North Schroeder Street, the north side of Lexington Street, and the west side of North Amity Street, subject to the conditions specified in this Ordinance.
- (b) The structure may not project into the public right-of-way more than 4 feet as shown on the structural plan entitled ♦Center/West 201 N. Schroeder Street, Block H, Sheet S1.01♦, as revised January 29, 2016.
- (c) Except as specifically provided in this Ordinance, all ordinances, rules, and regulations of the Mayor and City Council of Baltimore, including but not limited to the requirement to obtain a right-of-entry permit, must be complied with in the construction and maintenance of this structure.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect when it is enacted.
