AN ORDINANCE concerning

Repeal of Port Covington Urban Renewal Area and Plan

FOR the purpose of repealing Ordinance 87-1075, as amended by Ordinances 87-1179 and 88-1, which established the Port Covington Urban Renewal Area and Plan; and providing for a special effective date.

BY repealing Ordinance 87-1075

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That Ordinance 87-1075, which established the Port Covington Urban Renewal Area and Plan, as amended by Ordinances 87-1179, and 88-1, is repealed.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect when it is enacted.
