An Ordinance concerning

#### **Baltimore City Landmark List: Exteriors - George W. King/Abraham Briscoe House**

For the purpose of designating the George W. King/Abraham Briscoe House, 1232 Druid Hill Avenue, as an historical landmark: exterior.

By adding

Article 6 - Historical and Architectural Preservation  
Section(s) 17A-36  
Baltimore City Code  
(Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the Laws of Baltimore City read as follows:

**Baltimore City Code**

**Article 6. Historical and Architectural Preservation**

**Subtitle 17A. Landmark List: Exteriors - 2010s**

**§ 17A-36. George W. King/Abraham Briscoe House.**

George W. King/Abraham Briscoe House, 1232 Druid Hill Avenue.

**Section 2. And be it further ordained,** That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

**Section 3. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
